ACCEPTANCE OF RULES

PAYMENT OF MEMBERSHIP ACCOUNT

Payment of Membership Account, including all dues, fees and other applicable charges, is due upon receipt of the monthly statement. If accepted for membership, I/we agree to pay the account in full when due. I/we further authorize that any Member Account charges not timely paid may then be charged to any credit card that I/we provide to Apple Creek Country Club (Club) for such purposes. I/We agree and understand that a late charge up to the maximum amount allowable by law, or other penalties, may be assessed for past-due accounts as provided for in the Rules and Regulations of the Club, as amended from time to time. In addition to late fees, penalties may include, but are not limited to suspension of Club privileges and/or expulsion from membership. Payments on delinquent accounts apply first to reduce late charges and accrued dues, then to food and beverage charges, then to any other charges. Any fees assessed for untimely payment of any applicable dues, fees or charges will appear on my/our statement. I/We agree to pay all reasonable attorneys' fees, investigator fees, and costs in the event this account is turned over for collection.

I/we understand and agree that I/we must maintain my/our selected level of Membership for at least 12 months from the join date before downgrading or canceling my/our membership. In the event that I/we prematurely break this agreement, the Club has my/our permission to make a onetime charge to my/our credit card (unless other arrangements are made) for all outstanding dues and fees plus any remaining dues and fees which I/we would owe for the remaining term of the agreement. Following that initial period, my/our membership and these financial obligations shall automatically renew for an additional 12 months unless I/we give written notice to the Club at least 60 days prior to the end of my/our anniversary date.

BILLING AND DELIQUENCY

- 1) Club members will receive a statement each month for all fees and/or charges applicable for that month. Full payment of each month's statement balance (dated the last day of the month), is due by the 20th of the following month.
- 2) For those members, whose full payment has not been received the 20th of the month, a 1.5% interest charge, per month, will be charged to the member's account for the outstanding balance.
- 3) **Additionally**, for those members, whose full payment has not been received by the 20th of the month, a late fee up to \$50 may be charged to the member's account.
- 4) For those members, who fail to submit full payment by the last day of the month in which payment is due, all outstanding obligations shall become delinquent.
- 5) Notice of such delinquency shall be sent by mail or e-mail to such delinquent members at his/her billing or e-mail address as they appear in the records of the Club. Such notice shall inform the member that his/her membership is no longer in good standing. Such failure shall be reported to the President who may declare the membership terminated. The President shall have the right to postpone or withhold termination of membership if he determines such termination would be unjust, improper or inadvisable under the circumstances. Notice of termination of membership shall be sent by mail or e-mailed to the member at his/her address, but such termination shall not release any existing liability of the member to the Club, including current year future monthly dues payments.
- 6) **Reinstatement.** Any member, whose membership has not been suspended due to lack of payment, will have a 5-day waiting period, after full payment has been received, before their privileges will be reinstated.
- 7) If suit is filed to collect any obligation of a member, or any part thereof, the member agrees to pay associated court costs and reasonable attorneys' fees.
- 8) Notwithstanding that a member may have tendered his/her resignation or have ceased to be a member of the Club because of delinquency, death or otherwise, any sums due the Club shall be and remain a debt in favor the Club, enforceable against such member and his/her estate or assigns.

ASSUMPTION OF LIABILITY

I/we understand that as a Member of Apple Creek Country Club, I am assuming no liabilities whatsoever in connection with the Membership other than the payment of my/our Membership Fee or Membership Deposit, as applicable, monthly dues and charges incurred by me, my family and guests in use of the Club and that Membership does not confer upon me/us any ownership of the Club property or its assets. I/we understand that any use of the facilities at the Club by myself, my family and/or my guests is done at our own risk, and the Club is not liable for personal injury, theft, or loss of personal property, as further provided in the Rules and Regulations.
